

## Des Moines Valley Health and Human Services Data Practices Contacts

The **Responsible Authority** is the person who ultimately is responsible for the collection, use and dissemination of all entity data, and for all of the entity’s data practices decisions. The Responsible Authority also must make sure the entity complies with all of the requirements of the Act and the Rules.

The **Data Practices Compliance Official** is the person with whom the public may direct questions or concerns regarding problems in obtaining public data.

A **Designee** is a person designated by the Responsible Authority to help administer and implement the requirements of the Act and the Rules. A designee may receive and comply with requests for government data, and answer inquiries from the public concerning the provisions of the Act or the Rules.

The following have been designated in compliance with the Minnesota Government Data Practices Act.
